**ANNUAL PHYSICAL EXAMINATION FOR TEACHING
AND NON-TEACHING**

1. Pursuant to Republic Act 11223 or the Universal Health Care Act and its Implementing Rules and Regulations, and DepEd Memorandum 22, s. 2015 titled Annual Physical Examination of DepEd Employees, this Office informs all teaching and non-teaching personnel of the upcoming **Annual Physical Examination**.
2. Laboratory results shall be signed by a Medical Officer or any government or private physician for medical clearance and shall be collected by the District Nurse on or before April 15, 2025. Below is the list of required laboratory tests:
 - a) Chest X-Ray PA view (except for pregnant women)
 - b) ECG (for 40 years old and above)
 - c) Complete blood count and urinalysis
3. For those with pre-existing health conditions (e.g., hypertension, diabetes mellitus, chronic kidney disease, cardiovascular disease, etc.) please include the results of the following laboratory tests.
 - a) Fasting blood sugar
 - b) Cholesterol / lipid profile; and
 - c) Creatinine
4. Moreover, all DepEd employees registered with DepEd Bataan Provider are entitled to a complimentary annual check-up at the following accredited laboratories and hospitals, which the above-mentioned laboratory tests.
 - a) Dinalupihan District Hospital;
